<u>Public Comments:</u> Mr. Jim Bourgeois spoke about the services that One Acadiana provides such as staff support to JDEDC. One thing we are doing for this region is we spend a lot of time on recruitment.

<u>Old Business:</u> Discussions are being had with the Industrial Board to vet projects for both ITEP (Industrial Tax Incentives) and the PILOT Program (Payment in lieu of Taxes). Economic Development will vet the projects with the assistance of One Acadiana's economic modeling software. The project then will be presented to the Police Jury, School Board and Sheriff for approval. Economic Development will take the lead, through Ronnie, to set up a meeting with David Bruchhaus to discuss. The Industrial Board met to pull land

out of Pilot that was sold and added additional land bought by Rail Logix. Senator Theunissen is on the Industrial Development board. Rail Logix continues to market the site. Lacassine Operating Company (Catalyst plant) is a great economic driver for our parish and region. Ronnie and I presented the ITEP to the school board and the vote was unanimous. Mr. Eversul was delighted and said they are out there right now their doing their GO tech work. It should be six to nine months before they are up and ready. We are getting resumes from local people who want to apply for jobs with Lacassine Operating Company. We will send the resumes to his office in Houston.

GIS –According to Donald Kratzer most of the rural areas in the parish have be digitized. The first 6,600 parcels have been geo-rectified. Everything is moving along smoothly.
