<u>Old Business:</u> Creed Romano reported a very productive last official steering committee meeting for the LDRC certification program had been held. He was waiting on a draft from LED of the final version to review all the data collected from the past 6-8 months and make recommendations to LED if necessary.

Creed also reported he recently met with someone that owns land near the Lacassine Park for potential certification. Creed stated he was working with One Acadiana on leads. Zach Hager stated there was a point of opportunity to populate a request for information for land with rail. Creed stated LED requested to change the listing of the Zagis property from site to building to broaden the market and he also submitted pictures of inside of the building as per their request.

Ronnie Petree suggested planning a tour of Lacassine Park and also of a similar site in Mississippi.

Creed reported he attended a Delta Region conference and learned that request for funding projects needs to go through IMCAL.

Alex Guillory reported Representative Troy Romero had asked the Police Jury for a list of Capital Outlay projects. Some of the projects were water improvements for Lacassine Park area, renovate third floor of Parish Courthouse, bridges, sewer improvements for Lacassine and Roanoke, and turning lanes on Highway 101 near Henry's and the Lacassine Park.

New Business:

Ronnie Petree introduced Judy Petry as the new Economic Development Board Member filling Joel Oustalet's unexpired term. Her term will expire December 2024.

It was noted the next meeting would be held at noon on June 15, 2022.
