March had a 4% increase due to pandemic buying and April had decrease due to closures and stay at home orders. Jennings should end the year with a \$2 million surplus and will continue service agreements. Plans are to give employees a 2% cost of living raise.

Zack Hager reported One Acadiana has posted COVID-9 webinars and also a guide to navigate re-openings on their website.
